Since 1997 Mr. Bartosz Foroncewicz has been practicing medicine and is an assistant professor at the Clinic for Immunology, Transplantology and Internal Medicine at the Medical University of Warsaw.

In the years 1993-1996 Mr. Bartosz Foroncewicz worked in Nicholson International Ltd. in Warsaw as a researcher and as a consultant. Since 1997 Mr. Pan Bartosz Foroncewicz has been conducting economic activity as a partner in BiK s.c. with its registered office in Warsaw – a consultancy firm dealing with human resources management and employee recruitment.

Mr. Bartosz Foroncewicz is a partner in BiK s.c. Other than that, Mr. Bartosz Foroncewicz is neither a partner in any partnership, nor a partner in any other joint stock company. Mr. Bartosz Foroncewicz is also not acting as a member of authorities of any other joint stock company or partnership.
